### USES

Bostik Blu Tack Pink is the original reusable adhesive. It is supplied in the form of a rectangular slab between sheets of release paper and packed in individual wallets.

Bostik Blu Tack Pink is clean, safe and easy to use and provides an ideal alternative to drawing pins or sticky tape. It has over a thousand uses around the home, office and school, which include holding up posters, card, paper, party decorations, etc., sticking down objects to desks and shelves, photos in albums, screws to screwdrivers, and much more.

Bostik Blu Tack Pink is CE approved. Recommended for use on non-porous surfaces.

### DIRECTIONS FOR USE

### PREPARATION

1. Make certain that the surfaces to which Bostik Blu Tack Pink is to be applied are clean, dry and free from dust, grease and loose surface material.

### APPLICATION

2. Simply tear off the amount of Bostik Blu Tack Pink required, pull and stretch until supple, then roll into a ball. Place this between the surfaces to be fastened and press firmly.

### REMOVAL

3. To remove Bostik Blu Tack Pink roll it carefully off the surface. It can then be used again and again. Any remaining shreds can be removed by rolling or dabbing a blob of Bostik Blu Tack Pink over the surfaces.
4. The adhesive properties of Bostik Blu Tack Pink increase with time so take extra care when removing it after a period of months. On some surfaces Bostik Blu Tack Pink may leave an oily mark but lighter fuel (flammable) or proprietary chewing gum remover (non-flammable) can sometimes remove this.
5. The effect of these liquids on the particular surface concerned should first be tested on a small, inconspicuous area.

### PRECAUTIONS IN USE

Do not use Bostik Blu Tack Pink on absorbent, silk-screen printed or hand stencilled wallpaper, or on porous brickwork.


