### PREPARATION

1. The surfaces must be clean, dry and free from any dust or loose material.
2. For best results surfaces and surroundings should be pleasantly warm.
3. Take out the sheet of pads from the wallet and place on a firm surface.

### APPLICATION

4. Peel a pad off the sheet using fingers or gently with tweezers.
5. Press the pad onto one surface.
6. Peel the paper backing off the pad.
7. Press the second surface onto the pad.

8. Pads can be used together to create larger effects.

#### REMOVAL

9. Carefully and very, very slowly peel away to avoid damaging the surface.

#### PRECAUTIONS IN USE

Bostik Foam Pads are unsuitable for use on very absorbent, damp, dusty, delicate or newly decorated surfaces. If in doubt carry out a small test, first.
