PREPARATION

 The surfaces must be clean, dry and free from any dust or loose material.

APPLICATION

- Find the end of the tape and peel it away from the roll to the desired length.
- 3. Simply tear the tape or cut it with a pair of scissors.
- 4. Place the tape against the surface to be stuck and press firmly for a permanent bond
- 5. Be careful not to touch the adhesive side as it might become less sticky.

CLEANING

 Bostik Sticky Tape can be carefully peeled away from a hard surface.

PRECAUTIONS IN USE

Bostik Sticky Tape is unsuitable for use on very absorbent, damp, dusty, delicate or newly decorated surfaces. If in

doubt carry out a small test first. Place precisely onto gift wrap as removal will usually result in the paper tearing.

Please be aware that the adhesives get stronger with time so remove with care.
